Checklist for the Trial /Day of Wedding

**Wear a button down shirt*

**Come prepared with clean/dry hair for any Formal Styles, preferably washed/fully dried the night before.*

**Make sure you have with you any pictures to be used as visual aids for your Operator.*

**Bring in your tiara/veil/hair accessories/flowers you may like to use*

**If you have any special make-up you would like to use (For your convenience we do supply make-up from our own personal line for application and/or purchase)*

**Have with you any jewelry that will be worn the day of the wedding, to put the whole look together!*

***Please be sure to go over all information in this contract with all members of your bridal party before the day of services!*

Important Reminders

- 1. Any changes, cancellations or additions to bridal party appointments must be made through your Wedding Coordinator (Melissa Joyce).*
- 2. You have seven days prior to the date of your wedding to cancel any appointments. Any appointments cancelled less than a week prior to the wedding must be paid for in full. (No cancellations will be excepted unless made through your Wedding Coordinator)*
- 3. Prices for wedding services vary from prices listed in our standard brochure/menu. Please take note of the prices listed in your wedding contract.*
- 4. Go over all information, dates, and times to verify that everything is correct when you receive your copy of your contract.*
- 5. On the day of your wedding, if members of your party are more than ten minutes late, we cannot promise we will be able to fully accommodate them. PLEASE communicate the importance of being on time and prepared. Any Formal Design must have clean dry hair to start with.*

Price List for Wedding Parties

Formal Styles- an exact price cannot be quoted for a formal style. Prices are determined according to intricacy, length of hair, and time spent on the style.

A trial run is strongly recommended for the bride.

Your pricing list applies to both the trial and wedding day.

At the time of the trial all questions on pricing can be discussed and determined by your stylist.
